Agreement

The Social Development Institute, Inc. (hereinafter “the Institute”) from one side, and

(hereinafter “the Host Sponsor”) from another side, make this Agreement with respect to providing the host, care and supervision of the participant program’s student, which fly from Ukraine to the United States of America from January 01, 2010 to January 14, 2010 for cultural-educational trip by program “SDI-American winter”.

Thereto the Host Sponsor and the Institute conclude this Agreement about the following:

The Institute’s responsibilities to the Host Sponsor are:

FIRST: To meet the Host Sponsor or his (her) authorized delegate in JFK New York airport at January 01, 2010, to hand the designated student: _____, (from the Kyiv’s flight) to the Host Sponsor or his (her) authorized delegate.

SECOND: To meet the Host Sponsor or his (her) authorized delegate in JFK New York airport at January 14, 2010, receive the designated student from the Host Sponsor or his (her) authorized delegate and escort the designated student to boarding area for flight to Kyiv.

THIRD: To provide 2 (two) weeks free travel health-insurance coverage, free around New York City excursion’s ticket and free round trip flight form Kyiv to New York for the designated student.

FOURTH: To accept financial donation from the Host Sponsor for full coverage of stay financial expends (hosting, care, gifts, cultural-educational excursions, transportation, food, etc.) of the designated student and give to the Host Sponsor tax exam’s receipt for full amount of donation.

FIFTH: To provide full compensation of stay financial expends (hosting, care, gifts, cultural-educational excursions, transportation, food, etc.) of the designated student to Host Sponsor, according the Host Sponsor report.

The Host Sponsor’s responsibilities to the Institute are:

FIRST: To fill out Sponsor’s questionnaire for US participant of “SDI - American winter” program, and notify the Institute not later than two months before student arriving date in case of Agreement cancellation.

SECOND: To meet the Institute representative in JFK New York airport at January 01, 2010, accept (from the Kyiv’s flight) the designated student: _____, personally or by authorized delegate, and transport he (she) to the Host Sponsor’s house.

THIRD: To return designated student to the Institute representative in JFK New York airport at January 14, 2010, personally or by authorized delegate for escort the student to boarding area for flight to Kyiv.

FOURTH: To provide full board and lodging in Host Sponsor facility during the 2 (two) weeks from January 01, 2010 to January 14, 2010. Supervise behavior of the student, escort student personally or by authorized delegate during the travel from and to JFK New York airport and free time during the stay. To provide representation of student's parents in case of medical, legal and other emergencies or other events. To report to the Institute representative about any accidents which happened with student and coordinate with Institute all student activity, trips and entertainment.

FIFTH: To provide financial support by donation for full coverage of stay financial expends (hosting, care, gifts, cultural-educational excursions, transportation, food, etc.) the designated student.

SIXTH: To submit completely report of all stay financial expends (hosting, care, gifts, cultural-educational excursions, transportation, food, etc.) of the designated student, before the receiving of financial compensation.

I understand and agree with all statements of this Agreement and it is my responsibility to follow them. I represent that I do not have any criminal record and that I am otherwise competent and able to perform the terms of this Agreement.
